The specific purpose of this Corporation is improve the quality of life for the residents of the City of Stockton, California, and to re-create Stockton into a community of opportunity and hope for its citizens, especially its youth, through the sponsorship and funding of programs specifically designed to promote the redevelopment of the blighted areas of, and to attract outside investment into, the Stockton community.

Stockton Scholars is a place-based educational grant for graduates of Stockton Unified high schools to help them afford college or university. Starting with the graduating class of 2019, the Stockton Scholars program will provide every student going on to a 4-year university with \$1,000 a year, for a maximum of 4 years. Every student going to a community college, or to a qualifying trade program, will receive \$500 a year, for a maximum of 2 years. Students who receive an associates degree at a community college and then transfer to a 4-year university after will be eligible for an additional \$1,000 a year for 2 years while they pursue their bachelors degree. This money may be used for fees or tuition, and is distributed either to the students themselves or directly to the financial aid office of the institution that the student will be attending. In 2017, the Reinvent Stockton Foundation developed the plans for the Stockton Scholars, including through sending a delegation to the the 2017 PromiseNet convening in Kalamazoo, Michigan.

General Program - In order to prepare for the launch of the Stockton Scholars, Stockton Economic Empowerment Demonstration Project, and Stockton Advance Peace project in 2018, the Reinvent Stockton Foundation built administrative, operational and fundraising capacity in 2017. This included securing 501(c)3 status from the IRS, collecting research on these projects, and developing sustainability plans for each of these projects.

Program Launch - On January 16th, 2018, the Reinvent Stockton Foundation held a formal launch to announce the Stockton Scholars program. The event was held at the Bob Hope Theater in Downtown Stockton and the audience included over 400 high school juniors from Stockton Unified School District as well as local officials and potential donors. The event was designed to build community support and excitement for the program. The Foundation provided lunch and helped to coordinate transportation for all invited students in attendance. Throughout 2017, the Foundation organized the logistics for this ambitious event.
