OVER THE COURSE OF A YEAR, FELLOWS WILL PROVIDE ADDITIONAL READING AND WRITING TUTORING, PROMOTE RESTORATIVE JUSTICE AND SOCIO-EMOTIONAL WELLNESS, AND THEY WILL MENTOR YOUNG PEOPLE, PARTICULARLY FIRST GENERATION STUDENTS, AS THEY NAVIGATE HIGH SCHOOL AND TRANSITION TO AND THROUGH COLLEGE.
